



KYGO Sing To Meet Swift (the "Contest")

Official Contest Rules

- 2. HOW TO ENTER:** Registration period begins on Monday, February 15, 2010 and continues through 11:59pm Sunday, February 28, 2010. Log on to the KYGO website at www.kygo.com and click the contest link that for the KYGO Sing For Swift Contest. Then participants may upload a YouTube video no longer than 10 minutes in length. Name, address, phone number and age of the videographer must accompany videos. Only one entry per person will be permitted. All entries submitted become the sole property of the Station and will not be acknowledged or returned. Videos must be an original video created by the submitter. KYGO has the right to delete any entry knowingly received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act or any entry containing profane or objectionable subject matter or images. Participants may submit for a minor as long as they are the parent and/or legal guardian. The parent and or legal guardian must serve as an escort to the meet and greet should the winning video feature a person under the age of 15. Participants must be Team KYGO Members prior to participation. To join TeamKYGO participants may log onto www.kygo.com, complete the official online free registration form with their name, address, phone number, date of birth and a valid email address. Only one Internet entry per person and one Internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an Internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. All entries submitted become the sole property of the Station and will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. Station's computer is the official time keeping device for the Contest. All entries must be received by 11:59pm Sunday, February 28, 2010. The Stations assume no responsibility for entries not received. Then beginning Monday, March 1, 2010 through Friday, March 5, 2010 visitors to the KYGO website may vote for their favorite video.
- 3. WINNER SELECTION:** Then on or around Wednesday, March 10, 2010 one (1) Grand Prize Winner will be selected via the highest number of votes. Should a tie

occur, all tying participants will be entered into a random drawing and one participant will be selected as the Grand Prize Winner and the decisions of KYGO will be final. Odds of winning depend on the number of eligible entries received. One (1) Winner from participants who voted will also be randomly selected to win from all eligible entries received. Odds of winning depend on the number of eligible entries received.

The Grand Prize Winner may be asked for a cell phone number to assist in the receipt of Meet and Greet passes. Replacements tickets will not be provided. This Contest is not open to other Denver metro Radio/TV station employees, and their immediate families, agencies and representatives. The term "immediate family members" include spouses, grandparents, parents, siblings, children and grandchildren. No groups, clubs, or organizations may participate in this Contest or reproduce or distribute any portion of these rules to their members. Proof of age, identity, and eligibility must be furnished to the Station upon request. All entry form information must be complete and accurate. Winners of a major any Station contest (any contest with prizes valued over \$599) within the past six months are not eligible. The Station reserves the right to disqualify any entrant if these Contest rules are not followed.
